International Leadership Symposium 2012: Rethinking Capitalism

Throughout 2011, the world bore witness to fundamental transformations of the relationship between government and society across regions. The Arab Spring, aided by social media and communication technology, brought fundamental change to nations like Tunisia and Egypt. In India, the world's largest democracy, members of the public from all walks of life stood together as part of the India Against Corruption movement. In the West, movements like Occupy Wall Street sought to bring attention to issues of social and economic inequality, greed, corruption and the undue influence of corporations on government. This inexorable movement across sectors and countries toward stronger and stronger public demands for more open, inclusive, accountable and responsive governance underscore the need for leaders in government, the public, and the private sector to come together to find new, improved ways to collaborate.

2012 brought further economic uncertainty, which continues to take a heavy toll on growth prospects across the developing world and has led to stagnation throughout developed economies. The BRICS have seen their economies slow significantly. Unemployment remains at historically high levels globally and there no light has yet appeared at the end of the proverbial tunnel.

Is 2012 shaping to be a repeat of the 2008 economic crisis? Has capitalism failed? What are the lessons to be learnt? What role do human values and ethics play in overcoming the crisis? What steps can be taken to integrate these in the governance of public and private sector institutions? What type of leadership is required to take us forward?

The 2012 International Leadership Symposium of the World Forum for Ethics in Business explores the current global situation from a systemic perspective of multiple stakeholders. The Symposium will invite stakeholders from the public and private sector to challenge the status quo. The emphasis will be on identifying a roadmap that will take us forward on the path of sustainable growth.

Workshop 3: Open Governance: How Can Open Data on Companies Change the World? Equal access to core information is a fundamental principle of both free markets and an informed, active, functioning democracy. Unfortunately, too few countries make their company registers available as open data, and there are relatively few levers to encourage this. This session will discuss how governments enable transparency of information about registered corporations. The nascent Open Company Data Index will be presented, as well as how it can incentivize governments to increase transparency of their corporate registries, support civil society efforts related to corporate accountability, and generate richer, open-source, trans-national datasets, promoting innovation in governance applications and services.
